

The general validity period of lifting of food grains will be the last day of the month proceeding the allocation month. Cost of food grains should be deposited in advance so that the lifting is completed within the stipulated period.

The District Controllers must cause lifting and complete door-step-delivery to FPS Dealers within the stipulated period i.e. **10.10.2020 in terms of Memo No. 2451-FS dtd. 14.06.19.**

The distribution thereof will be made strictly adhering to the G.O. 149(2)-FS dtd 18.01.2016 and with a view to ensuring entitled food grains to the Ration Card holders, the G.O. No 70-FS dtd. 07.01.2016 shall strictly be followed.

The General Manager, F.C.I., West Bengal Region, is requested to ensure availability of wheat at the respective district depots and instruct the respective Area Managers of F.C.I. accordingly for smooth and speedy delivery of the same.
