CORRIGENDUM

In partial modification of Order No — 3901-FS/Sectt/Food/4P-18/2024 dated — 27/09/2024 on Policy and Guidelines for procurement of paddy from farmers at MSP during KMS 2024-25, the following corrections have been made :-

1. In the Para 14.2(G) - "Rice Mill of any category which submits BG and signs both agreements after 05.01.2024" shall be read as "Rice Mill of any category which submits BG and signs both agreements after 05.10.2024".

2. In Para 16.5 of the order- "One representative can be authorized for multiple purchase centers but multiple representatives cannot be authorized for a single purchase center at a time" shall be read as "One representative can be authorized for multiple purchase centers and multiple representatives can also be authorized for any purchase center at a time. However, one representative of a Rice Mill can not be tagged with more than one Rice Mill at any time"
