ORDER

The following 71 (seventy one) eligible Group D employees of different categories as mentioned in annexure A, now posted in different Directorates/Offices under this Department are hereby selected for promotion to the post of **Lower Division Assistants** of 10% quota under the pay structure of W.B.S. (ROPA) Rules,2019 in the Level-6 (₹ 22,700/- - ₹ 58,500/-) , along with allowances as admissible from time to time under the orders of the Government as per provisions laid down under notification no. **662-F(P2) dated 24.01.2019** of the Finance Department, in the interest of public service, until further order(s).

The incumbent may therefore be appointed accordingly on the terms and conditions as mentioned below:

- (i) The promotion will take effect from the date of issue of this order;
- (ii) The inter-se-seniority of the candidates will be determined in terms of West Bengal Services(Determination of the seniority) Rules 1981 later on;
- (iii) Before issue of order of the appointment so stated, the Deputy Secretary of this Department, being appointing authority in this regard, should be fully satisfied that the incumbent concerned is not hit by P&AR Department Memo No. 224(PAR)(Vig.) dated 12.06.1980 as amended subsequently and this should be mentioned in the order of the appointment;
- (iv) Annual Performance Reports and Reports on Integrity in respect of the concerned candidate should be examined properly so as to see that they are satisfactory;
- (v) If anyone of the incumbent fails to satisfy all the conditioned mentioned above, his/her name will not be considered for issuing order of instant promotion and his name will be deleted from the Selection list.

The present Director/Heads of the Offices of the incumbents named in the list should send the APRs, vigilance reports, in respect of the concerned candidates **to this Department within 30(thirty) days** from the date of issue of this Order without any delay on any ground. On receipt of the same, the Appointing Authority should, after observance of necessary formalities, issue order of appointment in favour of concerned candidate within 15(fifteen) days from the date of expiry of 30(thirty) days from the date of issue of the Order. The

concerned candidate should join their new assignment within 15(fifteen) days from the date of issue of order of appointment by the concerned appointing authority.

Further, no prayer for change of cadre would, under any circumstances, be entertained,

The services of those on deputation Directorates/Offices other than his/her parent Directorates/Offices shall be deemed to be withdrawn herewith.


