## **NOTIFICATION**

The State Government had earlier notified 99 mobile CPCs (m-CPCs) vide memo no. I/547699/2024 dated 14.08.2024 and 77 Mobile CPCs vide memo no. I/551310/2024 dated 28.08.24 in addition to already notified 614 Centralised Procurement Centres (CPCs) to cover maximum farmers under paddy procurement operations for KMS 2024-25 in the remote areas of the major paddy procuring Blocks to minimize the hardship of small and marginal farmers who can't wait for storing the paddy after harvest or who are unable to sale paddy at CPCs and DPCs for distance.

Now, in addition to the already notified 176 mobile CPC (m-CPCs) as mentioned above, another **2(two)** mobile CPCs, are hereby notified for KMS 2024-25 in the interest of paddy procurement operation from the small marginal farmers.

Them-CPCs will be run by the DCF&Ss from the location as detailed in table below:
