NOTIFICATION

No. 750-FS/Sectt/Food/4P-21/2024, Dated, Kolkata, the 25th February, 2025— Whereas it has been considered necessary to amend the West Bengal Targeted Public Distribution System (Maintenance and Control) Order, 2024, (hereinafter referred to as the said Control Order), in the matter hereinafter appearing;

NOW, THEREFORE, in exercise of the power conferred by section 3 and section 5 of the Essential Commodities Act, 1955(10 of 1955), the Governor is pleased hereby, with an immediate effect, the following amendments in the said Control Order, namely:-

Amendments

In the said Control Order,-

- (l) In clause 48, for the words and expression, "Part-I of Schedule C", substitute the following words and expressions, "Part-II of Schedule C".
- (2) In Clause 53, sub-clause (ix) shall be re-numbered as sub-clause (x) of that clause and before sub-clause (x), so re-numbered, *insert* the new sub-clause (ix) as follows:—
- "(ix) Any police officer not below the rank of Sub-Inspector of Police with prior intimation to the licensing authority and accompanied by an officer not below the rank of Sub Inspector of Food & Supplies Department".
- (3) In Part-I of Schedule C, for Serial No. (4), substitute the following:-
