NOTIFICATION

Sub: Enhancement of Additional Milling Charges

The approval of the Food & Supplies Department is hereby accorded towards enhancement of additional milling charges to the Rice Mills empanelled for Custom Milling of paddy from KMS 2024-25 onwards by Rs. 10/- per quintal of paddy over and above the existing additional milling charges of Rs.10/- per quintal of paddy being provided by the State in addition to Government of India (GoI) prescribed rate of Rs. 10/- per quintal and Rs. 20/- per quintal of paddy for raw rice and parboiled rice respectively for KMS 2024-25. Thus, the milling charges of paddy shall be Rs. 30/- per quintal and Rs. 40/- per quintal for raw and parboiled rice respectively w.e.f. KMS 2024-25. The above additional milling charges shall be provided by the State till enhancement of milling charges by GoI and refixation of the rates will be made subsequently.

This issues with the approval of the Finance Department in terms of U.O. No. Group A-II/2024- 2025/0087 dated 23/10/2024.
