Section-I

Introduction

Transportation of Gunny Bag bales from the storage Godown of the District to the Rice Mills of the same or other District is essential part of Procurement. With a view to determine the rate of Transportation of Gunny bags bales including handling, loading unloading etc. from designated Gunny Bags storage Godown to Rice Mills as per the provision of the extant Procurement Guideline issued by the Food and Supplies Department, Government of West Bengal. The Department of Food and Supplies, Government of West Bengal intends to invite Expressions of Interest (EOI) for entire Districts of West Bengal from Bonafide Transporter / Rice Millers having experience in Jute Bag bales handling located within the geographical boundary of the State of West Bengal for the purpose of determination of rate for transportation of Gunny bag bales including handling, loading, unloading etc. from designated godowns to Rice Mills. The rate will be valid for KMS 2024-25 and KMS 2025-2026. District wise existing list of empanelled rice mills and designated godowns are given at Appendix-I and II respectively. The authority reserves the right to cancel any or the entire tender process without assigning any reason thereof.

Section-II

Project overview and Scope of Work

- 1) The Rice Mills need to deliver Resultant Customed Milled Rice (RCMR) against the procured Paddy to different designated godown under state Government and FCI.
- 2) Food and Supplies Department, Government of West Bengal, procure the required Gunny bags to pack the RCMR, and store in different designated godowns of different district.
- 3) As per allocation of concerned District Controller, Food and Supplies (DCF&S), the concerned Rice Mill needs to take delivery of the Jute bag Bales from the designated Godown.
- 4) During taking the delivery of Gunny Bags bale from the allotted designated godown, the selected transporter will de-stack the Gunny bags bale, load the same to the truck/vehicle, carry the same to the Rice Mill point and unload the same in the Rice Mill.
- 5) The Rice Miller or his authorized representative shall satisfy himself as to the number of bales and weight & quality of Jute Bags loaded on the truck before preparation of the road challan as well before commencement of the journey.

- 6) The Godown In-charge shall issue requisite road challan in triplicate at the time of loading of Jute bags in truck for transportation of the loaded Jute Bales to the Rice Mill point after proper receipt from the Rice Miller or his authorized representative as per rules in force.
- 7) In case of any diversion of route other than the normal one due to some unavoidable situation on road or of the condition, the distance actually covered along the diverted route shall have to be certified by the concerned Distance Certificate Issuing Authority.
- 8) The selected transporter shall take all possible precautions to protect the Jute bags to be delivered from any sort of damages during the time of transportation and shall always cover the Jute Bales with tarpaulin sheets. They also shall take all efforts to protect pilferage, if any, during transportation. In this connection transit insurance of full value for the entire jute bags stock during transit are to be done by the Rice Miller.
- 9) In the event of mechanical disorder arising in the truck while at the loading points or en-route, cost of transshipment if any, shall be borne by the selected transporter himself.
- 10) No compensation shall be admissible to the selected transporter in respect of the detention of trucks in loading/unloading points or any other place(s) during transit.
- 11) The selected transporter as well as Rice Miller shall abide by all the instructions issued by the concerned authorities of Food & Supplies Department as well, from time to time.
- 12) In case any interpretation and/or clarification of any clause and/or clauses of this Tender document are required to be made, interpretation given by the TIA (Tender Inviting Authority) shall be final and binding upon the parties.
- 13) In case of any dispute and difference arising by and between the parties the same shall be referred to Arbitration which will be subject to the jurisdiction of the Courts at Kolkata only.

Section III

Application Procedure

Bidders are advised to study all instructions, forms, terms, requirements, and other information in the E-Tender document carefully. Submission of bid shall be deemed to have done after careful study and examination of the E-Tender document with full understanding of its implications. The response to this E-Tender should be full and complete in all respects. Failure to furnish the information required mentioned in the E-Tender documents or submission of a proposal not substantially responsive to the E-Tender documents in every respect will be at the bidder's risk and may result in rejection of its proposal. The E-Tender document is not transferable to any other bidder.

- 1. Bidders are to submit both technical and financial bids concurrently, digitally signed and uploaded in the website: www.wbtenders.gov.in.**

2. Registration of Bidder

Bidders willing to take part in the process of **e-tendering** will have to be enrolled & registered with the Government e-Procurement system through logging into the website **www.wbtenders.gov.in** and to click on the link for e-tendering site as given on the web portal.

3. Digital Signature Certificate (DSC)

Each participant, for submission of tender, is required to obtain a Class-III Digital Signature Certificate (DSC) from the approved service provider of the National Information Centre (NIC) on payment of requisite amount, the details of which are available at the Website.

4. Downloading

Bidders can download Notice Inviting e-Tender (NIT) & Tender Documents by logging into the website mentioned above using the Digital Signature Certificate. **This is the only mode of collection of Tender Documents.**

5. Deposition Of Earnest Money

Prospective bidders shall have to deposit an **Earnest Money of Rs. One lakh only for each bid** failing which the tender shall be summarily rejected.

This EMD challan shall form an essential document to be submitted with the tender. The deposited Earnest Money will not carry any interest.

6. Submission of Tender

- a. All Appendix attached with this Tender Document should be duly filled in and uploaded with digital signature in all pages. This is mandatory for considering any offer as valid.
- b. Tenders are to be submitted online in the website in the specified folders – one for Technical Details & the other for Financial Bid, before the prescribed date & time using the Digital Signature Certificate (DSC).
- c. The tenders of those who do not qualify the eligibility criteria shall be rejected at any time during detailed scrutiny and evaluation stage, to be done later on.
- d. Tender form downloaded in the name of the prospective bidder /firm alone should be used, otherwise it will be rejected.

7. Quotation of Rate

- a. The bidder must while quoting rate duly fill, sign and upload the prescribed BOQ, in the system. The rate shall include transportation of Gunny bag bales including handling, loading, unloading etc. from designated godowns to Rice Mills including all sorts of taxes and levies, if any except GST.

- b. The rate has to be carried out in the following 07 slabs and a bidder to quote his rate only for 1st slab. Before quote rate at 1st slab bidder should check the rate at remaining slabs which will be determined as per formula stated in the table as per distance.

- c. The financial rate of the bidder is to be submitted online only in prescribed BoQ, in the stipulated format of financial bid. Mentioning of rate anywhere else in the tender document shall make it liable to be rejected.

- d. The Financial bids of only the Technically Qualified Bidders shall be opened.

Section IV
Eligibility Criteria

1. Technical qualifications: A bidder shall be technically qualified if he fulfills the following criteria:

- 3) Photocopy of Certificate of Professional Tax with latest challan.

Section V

Evaluation and Selection

1. Technical Evaluation

- a. The TIA shall evaluate the Technical Proposal in terms of the Eligibility Criteria and the Documents submitted in support of the bid. To assist in the scrutiny, evaluation and comparison of the bids, the TIA may, at its discretion, ask any of the bidders for clarification on their bid on any of the points mentioned therein and the same may be sent through e-mail. No change in the prices or substance of the bid shall be sought, offered, or permitted, except to confirm the correction of arithmetic errors discovered by TIA at the time of evaluation of the bids.
- b. The TIA may also summon any of the bidders to seek additional information and documentation as well as the original hard copies of any of the documents uploaded by the bidder on the Portal, for purposes of verification. In the event the bidder does not submit such information and/ or documents to the TIA within the stipulated time, their bids may be rejected.
- c. Names of the technically qualified bidders will be notified through the e tender portal which the bidders may see through their own user ids.

2. Determination of Rate

- a. Financial bids of only the technically qualified Bidders shall be opened.
- b. Identification of bidder with lowest Financial Proposal (“**L1**”) will be determined as per the criteria below:
 - (i) The bidder who has submitted the lowest Financial Proposal as per the format provided in this EOI shall be termed as the L1 bidder;
 - (ii) The TIA may seek clarification of Financial Proposal from the L1 bidder if the quoted rate seems to be unjustified. If the rate quoted by a technically qualified bidder is found to be unjustified based upon the prevailing rates obtained through market survey/ Cost Analysis

etc. TIA has the authority to cancel the rate offered by L1 bidder. At the same time TIA shall have the right to debar the bidder from participating in any future tender process of the F&S Department on the ground of trying to vitiate the tender process for a period to be determined by the TIA with the approval of the competent authority.

c. Declaration of L1 rate

The rate provided by L1 bidder if found justified, will be declared as L1 or discovered rate for this EOI after approval from the competent authority.

4. Change in Scope of Work

- a. The TIA may at any time at its convenience and without assigning any reason whatsoever, change or modify the Scope of Work as mentioned in this document.
- b. The Bidders shall implement the change in Scope of Work promptly and in compliance with the terms of the Contract and the Order.

5. Validity of Offer

The determined of rate for transportation of Gunny bag bales including handling, loading, unloading etc. from designated godowns to Rice Mills will be valid for KMS 2024-25 and KMS 2025-2026.

Section VII

General Instructions to Bidders

1. Corrupt Practices

- a. The TIA requires bidders to observe the highest standard of ethics during the bidding process and during the Term and Renewal(s), as may be applicable; and
- b. The TIA may, if it determines that a bidder has, directly or through an agent, affiliate or associate has engaged in corrupt, fraudulent, coercive or restrictive practices in competing for, or in executing the Contract with the TIA:
 - (i) reject the bidder's proposal; and/ or
 - (ii) declare the bidder indefinitely or for a specific period of time, ineligible to participate in any tender/bidding process of the Department of Food and Supplies, Government of West Bengal and any of its directorates and undertakings; and/ or

2. Anti-Collusion

- a. The TIA reserves the right at its discretion to report suspected collusive or anti-competitive conduct by bidders to the appropriate regulatory authority and to provide the authority with all relevant information in relation to the same; and
- b. The bidder warrants that the bid has been prepared and submitted without any consultation, communication, contract, arrangement or understanding with any competitor regarding:
 - (i) Prices;
 - (ii) Methods, factors or formulas used to calculate prices;
 - (iii) The intention or decision to submit, or not submit a bid;

- (iv) The submission of a bid that is non-conforming; and
- (v) The terms of the bid.

3. Conflict of Interest

The TIA considers a conflict of interest to be a situation in which a party has an interest that could improperly influence that party's performance of official duties or responsibilities, contractual obligations, or compliance with applicable laws, and that such conflict of interest may contribute to or constitute a prohibited practice by the TIA, which requires that bidders under contracts with the TIA, observe the highest standard of ethics and will take appropriate actions if it determines that a conflict of interest has flawed the integrity of the bidding process. Consequently, all bidders found to have a conflict of interest shall be disqualified. A bidder may be considered to have a conflict of interest with one or more parties in this bidding process if, including but not limited to:

- a. they have promoters/ controlling shareholders/ partners/ designated partners/ proprietors/ management in common;
- b. they receive or have received any direct or indirect subsidy or financial grant or financial assistance from any of them;
- c. they have the same legal representative for purposes of this bid; or
- d. they have a relationship with each other, directly or through common third parties, that puts them in a position to have access to information about or influence on the bid of another bidder, or influence the decisions of the TIA regarding this bidding process.

4. Amendment of EOI

At any time prior to the last date of submission of bids, the TIA for any reason, whether at its own initiative or in response to a clarification requested by a prospective bidder, may modify the bid documents by way of an amendment or addition. Such modification shall be deemed to form an integral part of the EOI. Any such communication shall be posted on the Portal and bidders are requested to visit the Portal for updates.

5. Deviations

The bidder shall not be allowed to make any deviation whatsoever from the terms and conditions and technical specifications specified in the EOI. Further, the bidder shall be required to submit, as a part of its Technical Proposal, an undertaking that there is no deviation between the scanned copies of the original documents duly uploaded on the Portal vis-à-vis the physical copies of the original documents.

- 6. That all legal proceeding arising out of this Tender document shall be subjected to the exclusive jurisdiction of the Courts at Kolkata only.

7. That in the event of any dispute or difference of opinion or difficulty arising out of this Tender document regarding any stipulation therein or in respect of any matter relating thereto, the same shall be settled between the parties amicably failing which either party will be at liberty to refer the matter to the competent court of law within the jurisdiction of Kolkata for proper adjudication of the matter.
8. In case any interpretation and/or clarification of any clause and/or clauses of this Tender document are required to be made, interpretation given by the Director, Directorate of TIA shall be final and binding upon the parties.
9. In case of any dispute arising out of supply of Jute Bag bales the matter may be referred to the DCFS of the district where the procuring Rice mill is located for clarification.
10. It is not binding on the part of the TIA, to accept the lowest tender or any tender and he reserves the right to reject or accept all or any tender fully or partly, without assigning any reason thereof.
11. The firms/ companies who have been blacklisted or a process of blacklisting is pending against them, are debarred from participating in the tender process even if they happen to deposit Earnest Money.
12. Conditional Tenders bids shall not be accepted and will be summarily rejected.
13. The decision of the TIA after evaluation of the documentary evidences the eligibility of bidder shall be final.
14. The TIA reserves the right to reject any/all tender without assigning any reason thereof and the same should not be questioned, whatsoever.
15. Either party shall give to other party immediate information of any change of address and/or contact numbers within 48 (forty-eight) hours of any such changes.
16. Any notice to be served by either party on the other, on the other, shall be sent by email.
