

ORDER

Government in the Food and Supplies Department vide Notification No. 634-FS/Sectt./Food/4M-04/2021 dated 12.02.2021 has introduced a new Scheme "THE WEST BENGAL FAIR PRICE SHOP DEALERS (DEATH BENEFIT) SCHEME, 2021 in order to provide financial support to the family members to enable them to continue with their livelihood during times of family in distress as well as to provide social security to the members of the dealers family in the event of his/her death due to any cause, including natural death.

In terms of the Clause 5 of the said Notification, the eligible claimant shall be entitled for one time support of Rs.2,00,000/- (Rs.two lakh) only to be payable in one instalment but the modality of the disbursement of the benefit to the beneficiaries under the Scheme was not mentioned therein. Now, in view of the above, in terms of Clause 9 of the said Notification, Government in the Food and Supplies Department has decided to adopt the following procedure of disbursement of the benefit to the beneficiaries under the Scheme:

- 1) The DDO, of the office of DCF&S/DDR shall function as DDO for this purpose.
- 2) SCF&S/RO shall examine and process the claim and send the recommendation to DCF&S/DDR within 3 (Three) working days.
- 3) After the receipt of the claim for benefit under this scheme, DCF&S/DDR shall sanction the benefit within 3 (Three) working days and send the requisition for fund to the concerned Directorate through e-mail.
- 4) The Director of DDP&S/Rationing shall release the fund in IFMS within 3 (Three) working days to the DCF&S/DDR.
- 5) On receiving the fund, DDO shall submit the bill through e-billing module for disbursing the benefit within 2 (Two) working days.
- 6) The Budget Cell of this department will sub-allot fund to the concerned directorates as and when it is available from FD.
