ORDER

Sub: Verification of Bank Guarantee (BG) submitted by Rice Mills

In partial modification of the existing system of verification of Bank Guarantees submitted by the Rice Mills, the following procedure is hereby adopted-

- I. Rice Mill shall make entries/update the details of Bank Guarantee and upload the scanned copies in portal before signing of agreement and shall submit the original Bank Guarantees to DCF&S at the earliest.
- II. DCF&S shall verify the details of each Bank Guarantee submitted by a Rice Mill from the original copy. He shall mark "Verified from Original BG" in the portal and upload the scanned copies of Agreement in the portal on the same day but not later than next day under any circumstances.
- III. The Accounts Officer of the office of the DCF&S are hereby assigned the responsibility of verification of all the details of all BGs submitted by the Rice Millers from the issuing Bank within 14 days of uploading and verification from original BG by DCF&S. After verification of the BG of the Rice Miller from the issuing Bank, the same shall be marked "Verified from Bank" by the Accounts Officer in the portal using his login credential within 15 days of submission of the BG.
- IV. DCF&S shall make such necessary arrangements as required, in this regard.

This revised arrangement shall be effective from KMS 2025-26 onwards.

This issues with the approval of competent authority and smooth functioning of paddy procurement operations.
