Sub: Opening of m- CPC till March 2026- during KMS 2025-26.

The Department has issued the Policy and Guidelines for Procurement of Paddy from Farmers and Delivery of Custom Milled Rice (CMR) for Kharif Marketing Season (KMS) 2025-26 vide Order No. 4929-FS, dated 15.10.2025, wherein Clause 3 relates to Opening and Maintenance of Centralized Procurement Centres (CPCs) / mobile CPCs / Purchase Centres (PCs) run by Paddy Procuring Societies (PPS).

As per Sub-clause 3.4(v) of the said Policy and Guidelines, mobile CPCs are to remain functional during the peak procurement period from November, 2025 onwards till February, 2026.

The State Government has provisionally fixed a procurement target of 67 Lakh Metric Ton (LMT) of paddy (Common and FAQ varieties). In order to achieve the prescribed procurement target, prevent distress sale of paddy, and to ensure timely procurement and wider farmer participation, the following order is hereby issued in partial modification of Clause 3 of the aforesaid Policy and Guidelines for Procurement of Paddy from Farmers and Delivery of CMR for KMS 2025-26, Sub-clause 3.4(v) and shall be read as :-

“These mobile CPCs will remain functional till March, 2026”

All other terms and conditions of the aforesaid Policy and Guidelines and related orders shall remain unchanged.

This order is issued with the approval of the competent authority and in the interest of public service.
