#### **ORDER**

Sub: Format for "Daily Stock & Sale Register" to be maintained by every Dealer

All FPS Dealers shall have to maintain and update "Daily Stock & Sale Register" in prescribed format and preserve for at least five (5) years in pursuance of Clause 43 (2) of the West Bengal Targeted Public Distribution System (Maintenance & Control) Order, 2024.

In view of the aboveaformat for the "Daily Stock & Sale Register" to be maintained by every FPS Dealer has been devised by the Food & Supplies Department to maintain uniformity in this respect across the State.

Every FPS Dealer shall maintain separate card category-wise registers for AAY, PHH, SPHH, RKSY-I, RKSY-II and Special Package (wherever applicable) for every public distribution commodity (rice, wheat/atta, sugar).

Every register should have one or two pages designated for each month of a year. The Cover page of the register should bear the name of the FPS Dealer, FPS Code and License Code mandatorily. Every page should be numbered. A certificate that "This Register contains ..... pages" should be mentioned on first page.

All Dealers and Distributors shall hence forth ensure strict adherence in maintaining these formats. This Register will help the FPS dealer and Inspecting Official to quickly view the stock balance (both in the portal and physical register) and verify with physical stock.
