## Sub: Purchase Limit of paddy by the registered and validated farmer having no KB ID.

As per **Clause 8.4** of the 'Policy and Guideline for Procurement Paddy for KMS 2024-25' it has been mentioned that - 'A registered and validated farmer **who do not have KB-ID**, the limit on quantity of paddy as calculated depending upon land size cultivated and certified by BDO and productivity of the mouza of the/ block'.

Now considering the actual tilling of the land and paddy cultivation by the farmers who do not have KB ID, clause 8.4 above shall be modified as 'A registered and validated farmer who do not have KB-ID, shall be able to sell paddy as calculated depending upon land size cultivated in each season (Kharif and Rabi) and certified by BDO in each season (Kharif and Rabi) separately and productivity of the mouza of the/block'.

The other terms and conditions as laid down at clause 8 (**Purchase Limit** and **Payment to the Farmers**) of the '*Policy and Guideline for Procurement Paddy for KMS 2024-25*'shall remain unchanged.
