ORDER

The undersigned is directed to send a list of the name of 225 (two hundred twenty five) candidates presently holding the post of Group-D(Basic Grade) attached to the different Directorates of this Department for filling up, by promotion, the vacant post of Group-D(Grade-I) carrying pre-revised scale PB-I (Pay Band Scale Rs. 4900—16200/-) plus Grade Pay 1800/- i.e. Level-2 (Rs. 17600/- - 45200/-) along with other usual allowances as admissible from time to time as per WBS(ROPA) Rules, 2019.The Selection Lists of the candidates containing the names of the Directorates where they are now ordered to be allotted on promotion along with other relevant particulars are annexed herewith.

This selection has been made on the basis of the existing Gradation Lists concerned and while selecting the names of the candidates referred hereinabove, the Roster has properly been maintained.

The incumbents may, therefore, be appointed accordingly on the terms and conditions as mentioned below:

- 1) The promotion will take effect from the date of issue of this order;
- 2) The inter-se-seniority of the candidates will be determined later on in terms of W.B. Services (Determination of Seniority) rules, 1981;
- 3) Before issuance of order of appointment so stated, respective Appointing Authority should be fully satisfied that the incumbent concerned is not hit by P&AR Department Memo No. 224(PAR)(Vig.) dt. 12.06.1980 as amended subsequently and this should invariably be mentioned in the order of appointment;
- 4) Annual Performance Reports and Report on Integrity in respect of the concerned candidates should be examined properly so as to see that they are satisfactory and the same should also be mentioned in the order of appointment;
- 5) If anyone of the incumbents fails to satisfy all or any one of the conditions referred above, his name should not be considered for issuing order of appointment and his name should be referred to this Department immediately for it's deletion from the Selection List;

The present Directors/Heads of Offices of the incumbents should send the Annual Performance Reports, Vigilance Reports in respect of the concerned candidates to the Directorate/Office where their services are allotted to within 15(fifteen) days from the date of issue of this Order without any delay on any ground. On receipt of the same, the respective Appointing Authorities should, after observance of necessary formalities, issue order of promotion in favour of the candidates concerned within 15(fifteen) days from the date of expiry of 15(fifteen) days from the date of issue of this order. The candidates concerned should join their new assignments within 15(fifteen) days from the date of issue of order of

promotion by the concern Directorate/Head of Office, without fail, otherwise, the Order of Promotion will be deemed to have been cancelled on expiry of 45 (forty five) days from the date of issue of this order and the concerned Directorate/Head of Office should issue order of cancellation of Promotion Order in respect of the candidates concerned after the expiry of 45(forty five) days from the date of issue of this order under intimation to this Department with recommendation for deletion of the name(s) concerned (if any) from the Select List. Such non-acceptance of the instant promotion should also be recorded in the Service Book of the concerned candidate.

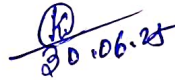
Also the unwilling incumbents must be transferred from his/her present place of posting and should not be returned to his/her present place of posting up to his/her next promotion. It is to be stated that the names of the candidates will not be considered further for promotion in this cadre before expiry of one calendar year from the date of issue of this order.

The stipulation of time mentioned hereinbefore should strictly be followed by all concerned.

Further, no prayer for change of allotment on promotion made hereupon should be entertained before joining of the incumbents concerned.

In case, there are cases of spelling errors in names, surnames or any type of clerical mistakes, that may be rectified by the concerned Directorates/Offices with an intimation to this Department.

The services of those on deputation to Dtes./ offices other than his/her parent Dte./office shall be deemed to be withdrawn herewith.

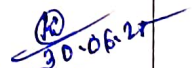

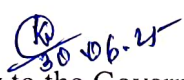
