## **ORDER**

In pursuance of the decision of the Government for procurement of paddy from small and marginal farmers at the Minimum Support Price (MSP) during KMS 2025–26 and in order to ensure necessary infrastructure at all CPCs including mCPCs, it has been decided to provide **Analysis Kits** (comprising Weighing Balance, Magnifying Glass, Scoops and Calipers) of specified specifications at all such centres for proper quality testing of paddy as per the PCSAP Grading Framework Checklist circulated by the Government of India.

Vide Order No. I/678716/2025 (E.1261120) dated 13.08.2025, 604 CPCs have been notified and vide Order No. I/678715/2025 (E.1261120) dated 13.08.2025, 175 mCPCs have been notified till date. Accordingly, sanction is hereby accorded for allotment of fund to the concerned DCF&Ss for procurement of 779 (Seven Hundred Seventy-Nine) Analysis Kits (604 for CPCs + 175 for mCPCs) @ ₹ 5,000/- (Rupees Five Thousand) only per set in favour of DCF&S from the Administrative Contingency fund under PDS as per the following table:-
