
#### **Sub: Transportation Charges for transportation of paddy and CMR for KMS 2025-26 onwards**

The Department has accorded approval towards payment of slab wise Transportation Charges with uniform rates for transportation of paddy (from purchase centers to tagged Rice Mills) and also intra-district as well as inter district transportation of CMR (from Rice Mills to designated depots) from the Kharif Marketing Season 2025-26, onwards, as per the following table:-

Sl. No.	Distance from loading point to destination point	Rates per quintal
1	<b>0 kilometer upto 8 kilometers</b> (From zero kilometer to less than or equal to eight kilometers)	<b>Flat Rate of Rs. 29.27</b> (Rupees Twenty-Nine and Twenty-Seven paisa only) per quintal.
2	<b>Above 8 kilometers upto 20 kilometers</b> (Greater than 8 kilometers and less than or equal to 20 Kilometers)	<b>Rs. 29.27</b> (Rupees Twenty-Nine and Twenty-Seven paisa only) per quintal upto 8 kilometers and further <b>Rs. 0.55</b> (Fifty-Five paisa only) per quintal per Kilometer beyond 8 kilometers upto 20 Kilometers.
3	<b>Above 20 kilometers upto 40 kilometers</b> (Greater than 20 kilometers and less than or equal to 40 Kilometers)	<b>Rs. 35.87</b> (Rupees Thirty-Five and Eighty-Seven paisa only) per quintal upto 20 kilometers and further <b>Rs. 0.50</b> (Fifty paisa only) per quintal per Kilometer beyond 20 kilometers upto 40 Kilometers.
4	<b>Above 40 kilometers upto 80 kilometers</b> (Greater than 40 kilometers and less than or equal to 80 Kilometers)	<b>Rs. 45.87</b> (Rupees Forty-Five and Eighty-Seven paisa only) per quintal upto 40 kilometers and further <b>Rs. 0.38</b> (Thirty-Eight paisa only) per quintal per Kilometer beyond 40 kilometers upto 80 Kilometers.
5	<b>Above 80 kilometers</b>	<b>Rs.61.07</b> (Rupees Sixty-One and Seven paisa only) per quintal upto 80 kilometers and further <b>Rs. 0.30</b> (Thirty paisa only) per quintal per Kilometer beyond 80 Kilometers.

The District Controllers, Food & Supplies shall assess, verify and incorporate the exact distances carefully in the Procurement/Billing portal for processing of claim for Transportation charges for transportation of paddy (from purchase centers to tagged Rice Mills) and also intra-district as well as inter district transportation of CMR (from Rice Mills to designated depots).

This issues with the approval of the Finance Department vide their U.O. No. Group A-II/2025-2026/0185 dt. 26/11/2025 and will remain in force until further order.
