NOTIFICATION

No. 4036-FS./Sectt./Food/4P-21/2024 – Kolkata, the 4th October, 2024, – **WHEREAS** it has been considered necessary to amend the West Bengal Targeted Public Distribution System (Maintenance & Control) Order, 2024, (hereinafter referred to as the said Control Order), in the manner hereinafter appearing;

NOW, THEREFORE, in exercise of the power conferred by section 3 and Section 5 of the Essential Commodities Act, 1955 (10 of 1955), the Governor is pleased hereby to make, with an immediate effect, the following amendment in the said Control Order, namely:—

Amendments

In the said Control Order, –

(1) in clause 41 –

(a) for sub-clause (i), *substitute* the following sub-clause:—

"(i) a license of a Fair Price Shop or Distributorship shall not be transferable, inheritable or convertible in the name of any other person or firm.";

(b) for sub-clause (ii), *substitute* the following sub-clause:—

"(ii) any person, as an individual or as a partner in a partnership firm, cannot hold a license for more than one fair price shops or distributorship. In case, a person is holding license as an individual or as partner in more than one fair price shop or distributorship, the license shall not be renewed after expiry of the validity. The benefit of appointment under chapter VI shall be available against only one such license provided other conditions are satisfied in this regard.";

(2) in clause 47, in sub-clause (2) and (3), for the words and figure "Part II of Schedule C" *substitute* the words and figure "Part I of Schedule C".

(3) in clause 48, for the words and figure "Part I of Schedule C" *substitute* the words and figure "Part II of Schedule C".

- (4) In Schedule-B,—
- (i) in the entry in column 5 against serial No. 2, for the bracket and figure "32 (8)" *substitute* the bracket and figure "32(9)".
 - (ii) in the entry in column 5 against serial No. 3, for the bracket and figure "32 (8)" *substitute* the bracket and figure "32(9)".
- (5) In Part I of schedule C, in the entry in column 2 against serial No. 4, *omit* the word, bracket and figure "sub-clause (2)".
