## CORRIGENDUM

In partial modification of the Order No CON-796/FS, dated 10.09.2025, the following entries are hereby amended as follows:

- 1. In Chain-6 Additional charge of Manbazar shall be treated as cancelled. ADCF&S Purulia will hold the additional charge of SCF&S, Manbazar until further order.
- 2. All LDTR and first moving officer (if he is not the LDTR) in the list, shall be released from LDTR / post in the afternoon of the 13.09.2025 with a direction to join new place on 15.09.2025.
- 3. The officers to whom they are releasing shall train / brief and guide them so that they are able to discharge their responsibilities properly during initial and festive days.
