- 5. The candidates already in Government service will have to furnish the release/resignation certificate issued from the competent authority before joining;
- 6. The incumbents are liable to serve anywhere in West Bengal as assigned by the Department;
- 7. He / She is requested to join the Directorate mentioned against his/her name as per column (7) within fifteen days from the date of issue of this order.
