## Sub: List of Forms to be used as prescribed proformas

The West Bengal Targeted Public Distribution System (Maintenance and Control) Order, 2024 has been notified vide notification no. 3139-FS dated 01/08/2024.

Department of Food & Supplies has also issued various "Forms" to be used as prescribed proforma for applications for dealership/distributorship, enquiry of such applications, issue of new dealership/distributorship licenses, renewal of existing dealership/distributorship licenses, etc. from time to time. However, it is felt prudent to modify/revise some of these Forms (prescribed proformas) by incorporating the provisions under various clauses of the West Bengal Targeted Public Distribution System (Maintenance and Control) Order, 2024.
