ORDER

Agent-wise allocation of Superior Kerosene Oil for the month of June, 2023

In pursuance of Para 5 (A) of the West Bengal Kerosene Control Order, 1968, as amended, read with Notification No. 2063-FS dated 11th July 2017 of the Food & Supplies Department, the SKO Agent-wise allocation of Superior Kerosene Oil (SKO) of **PASCHIM MEDINIPUR** district for **June, 2023**, is hereby issued as mentioned in the Table annexed hereto, adjusting the provisional Closing Balance stocks for May, 2023. 5 KL/Agent over and above normal net requirement is being allocated as monsoon reserve in pursuance with Department Order No. 157-FS/Sect./Food/6M-01/2013 dated 11.01.2023 read with this office Memo no. CG/K.Oil/ALLOT/11/06/Vol_XVI/774 dated 03.05.2023.

Excess quantities, over and above the requirement of distribution, being allocated to the Agents in multiple of 12 KL for the purpose of off-take from the terminals of Oil Marketing Companies in tank trucks as per the advisory of the Government of India, will be duly adjusted with the subsequent allocations.

All such aforesaid excess quantity may be stored using the storage capacities of the tagged SKO Dealers (including those of Bulk Supply) after using full capacity of the concerned SKO Agent. SCF&Ss will issue formal sub-allocation order in this regard prohibiting distribution of such advance quantity in PDS in the current month.

Each Agent shall sell SKO at the price determined by the competent authority corresponding to the prevailing base price of the Oil Marketing Company on the date of off-take from its terminals.

Each Agent shall upload the Closing Balance of SKO for June, 2023 **within 30/06/2023** after distribution of allocation herein to the dedicated webportal dcgfood.wb.gov.in as per Order No. 3681-FS dated 31st December, 2018 read with no. CG/K.Oil/Allot/141/2019/1506 dated 27th November, 2020 of the Food & Supplies Department. The SCF&Ss and DCF&Ss (DD, CG in case of Kolkata and Bidhannagar) will verify and approve the same in the webportal **within 01/07/2023**.

Any lapse in duty or wrong reporting on the part of an Agent, if detected subsequently, will be subject to adjustment with the monthly sub-allotment and will attract penal action in terms of West Bengal Kerosene Control Order-1968, as amended.

This has got approval of the Director of Consumer Goods.
