ORDER

Since the quantum of paddy procurement is huge in this procurement season (KMS 2020-21) and as the farmers need to be saved from distress sale of paddy during this pandemic time, the dispatch of paddy to the Rice Mills of different procuring districts needs to be streamlined immediately. The restriction on dispatch of paddy quantum to a Rice Mill upon delivery of resultant CMR was examined thoroughly with the Bank Guarantee submitted by the Mill.

In continuation of the Notification No. 2771-FNS dated 11th November'2020 read with No. 3158-FNS dated 24.12.2020 and 3239-FNS dated 31.12.2020., it is decided that on being satisfied as regards CMR delivery by the concerned Rice Mill and need of farmers of that area, the concerned DCF&S may relax the paddy procurement limit of that Rice Mill by mentioning reasons in the portal against the given Bank Guarantee upto additional 50% of the existing limit by himself and thereafter upto 100% of the existing limit subject to approval of the Director of DDP&S.

The relaxation on paddy holding limit as mentioned in aforesaid notification No. 3158-FNS dated 24.12.2020 and this order will remain applicable till 28th February'2021.


