NOTIFICATION

No. 1655-FS/Sectt./Food/4P-06/2021 dated 4th June,2021. – WHEREAS the Governor is of the opinion that it is necessary and expedient to do so for the maintenance of supplies and for securing the equitable distribution and availability at fair prices of Superior Kerosene Oil in all parts of West Bengal;

NOW, THEREFORE, in exercise of the powers conferred by sub section of section 3 of the Essential commodities Act,1955 (Act 10 of 1955), read with Clauses (d), (e), (h) and (i) of sub section (2) of that section and sub section (1) of section 7 of the said act and Order No. S.O. 681(E) dated the 30th November, 1974 of the Government of India, Ministry of Industry and Civil Supplies (Department of Civil Supplies and Co operation), the Governor has been pleased hereby to make the following amendments in the West Bengal Kerosene Control Order, 1968, as subsequently amended (hereinafter referred to as the said order):—

AMENDMENTS

- 1. In clause 3,
 - (1) for sub-clause (h), substitute the following sub-clause:-
 - '(h) "dealer" means an individual person, or a registered partnership firm, or a registered Cooperative Society, or a Sangha or mahasangha of Self-Help Group working within a district in whose name a licence to sell S.K Oil under the Public Distribution System has been issued under clause 6.';
 - (2) for sub-clause (1), substitute the following sub-clause:-
 - '(1) "family member (s)" means
 - (i) spouse; or
 - (ii) parents; or
 - (iii) son (including legally adopted son before death or incapacitation); or
 - (iv) widow of pre-deceased son; or

(v) daughter (including legally adopted daughter before death or incapacitation);

who is wholly dependent on the dealer at the time of death.';

- (3) after sub-clause (s), insert the following sub-clauses:-
 - '(si) "relative" includes the family member and the following kin:-
 - (i) son's spouse, son or daughter;
 - (ii) daughter's spouse, son or daughter;
 - (iii) brother's spouse, son or daughter;
 - (iv) sister's spouse, son or daughter;
 - (v) parents' brother or sister;
 - (vi) spouse's brother or sister.;'
 - (sii) "Permit" means permission for availing a fixed quantum of SK Oil outside Ration Cards for a specific period of time.'
- 2. In clause 5,
 - (1) for sub-clause (i), substitute the following sub-clauses:-
 - "(i) The Director of Consumer Goods with prior approval of the State Government will communicate to the Oil Marketing Companies the area where requirement of engagement of an Agent has arisen clearly delineating a landmark defining central location of such vacancy area.
 - (ia) The Director of Consumer Goods shall, on receiving an application in Form A or Form A1, as the case may be, from a person or a registered Co-operative Society or a registered Company or a partnership firm, who/which has/have executed an Agreement with an Oil Marketing Company authorizing him/such registered co-operative society/company/partnership firm to carry on trade in Kerosene as Agent under PDS in West Bengal along with application fee as mentioned in Schedule A, cause an enquiry and issue an offer letter in Form-O1 or O2, as the case may be, to the approved candidate/organisation with the direction for furnishing recent passport size photograph(s), security deposit, licensing fee as per Schedule-B and other requisite documents.
 - (ib) The Director of Consumer Goods shall, on receipt of the documents mentioned in sub-clause (ia), issue license in Form B.";
 - (2) for sub-clause (vii), substitute the following sub-clause:—
 - "(vii) In case of dissolution of partnership, the reconstituted partnership or proprietorship firm will enter into fresh agreement with concerned Oil Marketing Company and submit application along with copy of fresh agreement for issue of fresh licence to the licensing authority."
 - (3) for sub-clause (x), substitute the following sub-clause:—
 - "(x) License fee as mentioned in Schedule-A for issue of licence shall be paid in such manner as may be specified by the State Government".
- 3. For clause 6 *substitute* the following clause:-
 - "6. Engagement of Dealer.-
 - (i) In the event of -
 - (a) Resignation of any dealer

(b) Death or incapacitation of the existing individual dealer or one/ more than one of the partners of the existing partnership firm on medical ground, unless any of the deceased/incapacitated proprietor's/partner's family members is found suitable for engagement on compassionate ground as per paragraph 6 (viii) within the given time frame,

Or

(c) Dissolution of a Cooperative Society or Sangha/ Mahasangha of Self-Help Group,
 Or

(d) termination of a Dealer,

the resultant vacancy has to be notified by Sub-Divisional Controller, Food & Supplies or Director with prior approval of the State Government:

Provided that no resultant vacancy against a deceased or terminated dealer supplying S.K. Oil in bulk to other dealer(s) shall be notified under any circumstances.

- (ii) If it appears necessary to declare a new vacancy for catering to the need of the consumers in any particular area, the vacancy has to be declared by the Licensing Authority with the approval of the Department as per following procedure:
 - (a) In case of resultant as well as new vacancy, the Sub-Divisional Controller, Food & Supplies shall submit the proposal of vacancy of dealer to the District Controller, Food & Supplies, who in turn, will send to the Director with concurrence of the District Magistrate. The Director of Consumer Goods will examine the proposal and if necessary, make re-enquiry and send the proposal to the Department for approval:

Provided that for the vacancy in Kolkata and Bidhannagar area, the Director herself/himself will initiate the proposal and send it to the Department for approval.

- (b) After obtaining approval of the State Government, the vacancy shall be declared stating eligibility criteria through notice in the office notice board, *Official Gazette* and advertisement in a local as well as in a widely circulated daily newspaper. The last date of receiving applications against a vacancy shall be thirty days from the date of Gazette notification or newspaper advertisement, whichever is later.
- (c) Applications for filling up the vacancies as notified in sub-clause (i) and (ii) hereinbefore shall be invited from an individual, registered partnership firm, registered Co-operative society, Sangha or mahasangha of self-help group working within a district. In case of fresh vacancy preference may be given to Sangha or Mahasangha of Self-Help Groups, especially women-run one. If applicant be individual(s), he/she/they should be permanent resident of the concerned sub-division and for other entities they must be working in the sub-division where the vacancy is notified:

Provided that, if the State Government so desires, it may give such opportunity to only Sangha or mahasangha of self-help group and registered Co-operative society by separate notification.

- (iii) Following person shall not be eligible to apply for a licence of a dealer, namely-
 - (a) a person holding a license of S. K. Oil dealer or S.K. Oil Agent or FPS Dealer or Distributor or Wholesaler in his name or a relative of such licensees;
 - (b) a member of local bodies, local authority, Panchayati Raj Institutions, board or corporation, or Member of Legislative Assembly or a Member of Parliament during his tenure as such capacity;
 - (c) a minor or person of unsound mind or an insolvent;
 - (d) a person convicted by the court under the Act or in any other criminal proceedings connected with essential commodities;
 - (e) a person holding a post in the establishment of any State Government or Central Government or any authority or body or institution of Local self-government established or constituted by or under the Constitution or by any other law made by the Parliament or a State Legislature or by notification issued or order made by the Central Government or a State Government;
 - (f) a limited liability partnership;
 - (g) a corporation or company:

Provided that nothing in this clause shall affect the continuance of existing dealer.

- (iv) The applications received in Form-D along with checklist appended therewith and requisite fee as prescribed in Schedule-B within the stipulated time shall be enquired by the Sub-Divisional Controller, Food & Supplies or Area Inspector of Consumer Goods, and the report so prepared shall be sent with his comments to the concerned District Controller, Food & Supplies or the Assistant/Deputy Director of Consumer Goods, as the case may be, within one month from the last date of receipt of the application as notified.
- (v) On receipt of the report, the said District Controller, Food & Supplies or the Assistant/Deputy Director of Consumer Goods, as the case may be, examine the case and shall forward the same with his comments to the Director of Consumer Goods, within a month from the date of receipt of the report. For the purpose of this sub-clause the District Controller, Food & Supplies will take concurrence of the District Magistrate concerned before sending it to the Director of Consumer Goods.
- (vi) The Director of Consumer Goods, if necessary, may arrange for further enquiry into the matter by any competent officer or by a team of officers and thereafter shall accord approval selecting the most suitable candidate for filling up the vacancy.
- (vii) Notwithstanding anything contained in this clause, the State Government may, for the reasons to be recorded in writing, cancel the vacancy at any time before the approval is granted.
- (viii) After obtaining approval of Director, the Licensing Authority shall issue an offer letter in Form-O3 to the approved candidate/organisation with the direction for furnishing recent passport size photograph(s), security deposit, licensing fee as per Schedule-B and other requisite documents.
- (ix) Engagement on compassionate ground:-
 - (a) In case of vacancy arising out of death or in case of incapacitation on medical ground, subject to satisfaction of the authority, of any existing dealership run by individual person, such vacancy shall not initially be notified. Prayer of any of the family members of the deceased or incapacitated dealer having no regular means of income, shall be considered with preference on compassionate ground provided such prayer along with formal application in form D1 along with checklist appended therewith and requisite fee is submitted within 90 days from the death or incapacitation. However, the licensing authority may, on just and sufficient grounds shown by the applicant and for the reasons to be recorded in writing, accept such application upto 120 days:

Provided that while applying, the applicant shall have to furnish "No Objection" in Annexure-II from other family members in the form of an Affidavit executed before a Magistrate except in the following cases:

- (A) If the applicant be the spouse of the deceased licensee,
- (B) If the ex-licensee, because of his being incapacitated/infirm has opted for the applicant.
- (b) In case of death of individual licensee, the Licensing Authority shall forthwith de-link all ration cards from the deceased Dealer and temporarily re-link with nearby Dealer(s) as per convenience of the beneficiaries up to the period of filling up the vacancy.
- (c) The Sub divisional Controller, Food and Supplies shall arrange for an enquiry to verify the eligibility of the applicant and submit the report with his opinion to the District Controller, Food and Supplies. While forwarding a case on medical ground the Sub divisional Controller should satisfy himself on examination of the medical prescription and certificate issued by a Registered Medical Practitioner that the licensee is not in a position to run dealership business considering his health ground. The District Controller, Food & Supplies shall submit the same with his comments before the District Magistrate for final approval:

Provided that in case of Kolkata and Bidhannagar area the functions of Sub divisional Controller, Food and Supplies, District Controller, Food and Supplies and District Magistrate respectively will be discharged by the Area Inspector, Assistant/Deputy Director of Consumer Goods and Director.

- (x) On approval of the case, the Licensing Authority shall issue an offer letter in Form-O4 to the approved candidate, directing him to furnish recent passport size photograph(s), security deposit, licensing fee as per Schedule-B and other requisite documents.
- (xi) On receipt of such requisite document and fees as mentioned in the offer letter under clause (viii) and clause (x), the Licensing Authority shall issue licence. Failure to comply with the direction in such offer letter on the part of the selected candidate/organisation shall make the candidature liable to be cancelled. In such case, the Director of Consumer Goods, in exercising her/his discretion shall select the next suitable applicant or declare the vacancy afresh, as the case may be.

(xii) Whenever –

- (a) an individual licensee opts to convert its business into partnership firm for the reason of his physical incapacitation, or
- (b) a licensee of a partnership firm opts to induct a new partner or substitute the name of an existing partner,

the licensing authorities may, on an application made by the licensee on this behalf, allow him to do so with the approval of the State Government, if and only if any of the family member of licensee having no regular means of income is inducted or substituted as partner and not otherwise:

Provided that in case of death of one of the partner of a partnership firm comprising of only two partners having the dealer's license, the surviving partner shall reconstitute the partnership firm by inducting only the family member of the deceased partner having no regular means of income and not otherwise:

Provided further that -

- (A) in case of death of a partner of partnership firm having the dealer's license, the licensing authorities may, on an application made by the surviving partner, allow him to continue the business for a period of ninety days or till the new license is granted, whichever is earlier;
- (B) in case of death of a partner of partnership firm having the dealer's license and if no eligible family member(s) is found to become the partner or partners, as the case may be, of the said partnership firm, the surviving partner, may apply for the conversion, before the licensing authority, and upon satisfaction of the licensing authority, the said surviving partner will be allowed to continue the business, as a sole licensee, subject to the approval given by the Director in this behalf:
- (C) Provided also that in case of death of an individual licensee, the eligible family member or members, as the case may be, may apply before the licensing authority, for running its business, either as an individual licensee or as the registered partnership firm, subject to the approval given by the Director in this behalf.
- (xiii) In case the District Magistrate delegates the power of licensing authority to an official other than Sub-Divisional Controller, Food & Supplies the functions assigned to Sub-Divisional Controller, Food & Supplies herein would be discharged by such official. However, the functions assigned to the District Magistrate in this order cannot be delegated to any officer below Additional District Magistrate.
- (xiv) The State Government may reserve the right to conduct the entire aforementioned workflow online through a web portal."
- 4. For clause 7, *substitute* the following clause:
 - "7. Renewal of licenses of Agents.- (i) Every licence issued under clause 5 of this order shall be valid up to 31st December of the year in which it has been issued. Thereafter such licence shall be renewed for successive period of three years at a time subject to satisfactory performance and confirmation of the Agent. However, all the ancillary certificates/licences/documents required for renewal of licence will have to be submitted within one month of expiry of the validity of the said documents.
 - (ii) The licensee shall submit the application for renewal of licence in Form C within the period of validity to the licensing authority together with the renewal fee as mentioned in Schedule-A and required documents specified for the purpose.

(iii) If the licensee fails to submit the application for renewal within the period of validity, he may submit application for renewal of licence within 30 days from the date of expiry of validity of licence on payment of such fine as specified in Schedule-A and required corroborative documents:

Provided that the licensing authority may allow a licensee to submit renewal Form beyond 30 days from the date of expiry, as mentioned above and up to a period of next 60 days, on realization of the fine specified in Schedule -A and the required documents, if it thinks that non-submission of renewal Form was beyond the control of the licensee.

- (iv) The licensing authority shall, on receipt of the application of renewal under sub-clause (ii) or sub-clause (iii), as the case may be, renew the licence.
- (v) If the licensee fails to submit the renewal Form as per sub-clause (i) or sub- clause (ii), as the case may be, the licensing authority may terminate his license from the 1st day of April of the year, in which such renewal was due, and also take administrative and legal action against the licensee, so terminated, for smooth running of the public distribution system in the interest of public.
- (vi) If a licence granted under this order is defaced, lost or destroyed, the licensing authority may issue a fresh licence in place thereof on payment of a fee as mentioned in Schedule A hereinafter, which shall be payable in the form as prescribed by the State Government and thereupon the licence that has been defaced, lost or destroyed shall be deemed to be cancelled.
- (vii) The process of renewal shall be carried out in online mode only. ";
- 5. For clause 7(A) and the Schedule thereof, the following clause and schedule thereof,
 - "7A. Renewal of licenses of Dealers. (i) Every licence issued under clause 6 of this order shall be valid up to 31st December of the year in which it has been issued. Thereafter such licence shall be renewed for successive period of three years at a time subject to satisfactory performance and confirmation of the dealer. However, all the ancillary certificates/licences/documents required for renewal of licence shall have to be submitted within one month of expiry of the validity of the said documents.
 - (ii) The licensee shall submit the application for renewal of licence in Form F within the period of validity to the licensing authority together with the renewal fee as mentioned in Schedule-B and required corroborative documents.
 - (iii) If the licensee fails to submit the application for renewal within the period of validity, he may submit application for renewal of licence within 30 days from the date of expiry of validity of licence on payment of such fine as specified in Schedule-B and required corroborative documents.

Provided that the licensing authority may allow a licensee to submit renewal Form beyond 30 days from the date of expiry, as mentioned above and up to a period of next 60 days, on realization of the fine specified in Schedule -B and required corroborative documents, if it thinks that non-submission of renewal Form was beyond the control of the licensee.

- (iv) The licensing authority shall, on receipt of the application of renewal under sub-clause (ii) or sub-clause (iii), as the case may be, renew the licence.
- (v) If the licensee fails to submit the renewal Form as per sub-clause (i) or sub- clause (ii), as the case may be, the licensing authority may terminate his license from the 1st day of April of the year, in which such renewal was due, and also take administrative and legal action against the licensee, so terminated, for smooth running of the public distribution system in the interest of public.
- (vi) If a licence granted under this order is defaced, lost or destroyed, the licensing authority may issue a fresh licence in place thereof on payment of a fee as mentioned in Schedule B hereinafter, which shall be payable in the form as prescribed by the State Government and thereupon the licence that has been defaced, lost or destroyed shall be deemed to be cancelled.
- (vii) The process of renewal shall be carried out in online mode only. ";

"(iv) On receiving reply from the Agent, the DCG after giving the licensee an opportunity of being heard and after recording the reasons thereof, may terminate the Agency or reduce the volume of business through reduction of tagged dealers and / or impose a fine as described in Schedule E and of course according to the gravity of the offence. In case of imposition of fine, the fine shall be payable in the form as prescribed by the State Government."

7. for sub-clause (iii) of clause 9A, *substitute* the following sub-clause:

"(iii) The DCG in Kolkata and Bidhan Nagar areas or the District Magistrate in the districts after giving the licensee an opportunity of being heard and after recording the reasons thereof, may terminate the Dealership, reduce the volume of business through reduction of tagged ration cards and / or impose fine mentioned at Schedule E and of course according to the gravity of the offence. In case of imposition of fine, the fine shall be payable in the form as prescribed by the State Government."

(8) for "Schedule E", substitute the following Schedule: –

 - (ii) The District Magistrate may issue a Permit to an S.K. Oil Agent within the district concerned for the same purpose, if required, to organisations mentioned at (i) (a).
 - (iia) Requirement of issue of a Permit shall be subservient to availability of adequate stock only after requirement of PDS beneficiaries in the concerned area has been met."
 - (2) for sub-clause (iv), substitute the following sub-clause:
 - "(iv) In case no S.K. Oil Agent is available in a Sub Division where S.K. Oil Dealer/s is/are located or in case area under an Agent falls deficient due to temporary lack of functioning/non-functioning of the Agent, the DCFS will issue Order for the concerned distribution month to an S.K. Oil Agent of another Sub Division or area respectively, for supplying SK Oil to the deficient S.K. Oil Dealer/s with the approval of the District Magistrate in such case. In Kolkata and Bidhan Nagar areas, Chief Inspector/Inspector of Consumer Goods may issue such Order with approval of the Joint/Deputy /Director of Consumer Goods, who act on delegated power."

- "1. The licensee may purchase PDS kerosene from any S. K. Oil Agent or subject to approval of the licensing authority, from any other dealer supplying S.K. Oil in bulk as per allocation order/programme made by the licensing authority.
- 2. The licensee shall sell kerosene at a price and scale fixed by the licensing authority, to a ration card holder or subject to approval of the licensing authority, to other dealer or permit holder, as the case may be.".
