Sub : Distribution of foodgrains under One Nation One Ration Card (ONORC) to the NFSA (AAY/PHH) beneficiary of other States who has migrated in West Bengal at free of cost.

Government of West Bengal in the Food & Supplies Department has decided to implement the One Nation One Ration Card (ONORC) plan under the scheme of Integrated Management of Public Distribution System (IM-PDS) with the aim of nation-wide portability in the distribution of subsidized food grains to eligible nation card holders under NFSA who migrate/move across States/UTs in search of temporary employment /work or other reasons.

Government of West Bengal in Food & Supplies Department has been providing food grains to all PDS beneficiary (NFSA & RKSJ) of this State free of cost in terms of this office Notification No.1977-FS dt. 22.07.2020 and subsequent Notification No.2029-FS dt. 22.06.2021. As a result, all the PDS beneficiaries of West Bengal are not being charged for their normal entitlement of food grain under NFSA.

In consideration of the above facts and the hardship of the migratory NFSA beneficiary of other State /UT who has moved in West Bengal in search of temporary employment/work or other reasons, the Government of West Bengal has decided to provide food grains to all such migratory NFSA beneficiary free of cost from any FPS of West Bengal until further order.

This is issued with the approval of competent authority of the Government of West Bengal.
