4. Service Seniority will be determined according to the West Bengal Service (Determination of Seniority) Rules 1981, read with provisions of Finance Department's Notification No. 1832-F(P) dated 01.03.2013 and amendments from time to time;
5. The candidates already in Government service will have to furnish the release/resignation certificate issued from the competent authority before joining;
6. The incumbents are liable to serve anywhere in West Bengal as assigned by the Department;
7. He / She is requested to join the Directorate mentioned against his/her name as per column (7) within fifteen days from the date of issue of this order.
