NOTIFICATION

No. 85-FS./Sectt/Food/4P-09/2012(Part III), - Kolkata, the 5th December, 2023. - WHEREAS it has been considered necessary to amend the West Bengal Public Distribution System (Maintenance & Control) Order, 2013, as subsequently amended (hereinafter referred to as the said Control Order), in the manner hereinafter appearing;

NOW, THEREFORE, in exercise of the power conferred by section 3 of the Essential Commodities Act, 1955 (10 of 1955), the Governor is pleased hereby to make, with an immediate effect, the following amendment in the said Control Order, namely:—

Amendment

In the said Control Order,-

- (1) the provisions under clause 20A shall be re-numbered as sub-clause (2) of that clause and before the said sub-clause (2), so re-numbered, following sub-clause shall be inserted:-
 - "(1) In case a Dealer has resigned or his license has been suspended, or cancelled or terminated, the concerned Licensing Authority tags the ration cards of such Dealer to a nearest fair price shop.".
- (2) after clause 27, insert the following clause:-
 - **"27A.** Bar to shifting of shop and/or godown. (1) After the grant of a license under this Control Order, a licensee shall not be permitted to shift his shop and/or godown save and except on the following rounds:–
 - (i) It is not possible to run the business due to dilapidated condition of the existing shop and/or godown; or
 - (ii) The beneficiaries tagged with the fair price shop are facing inconvenience due to location of the shop and/or godown at far distance;
 - (iii) The licensee is evicted from the premises by virtue of Court order;
 - (iv) The location of the shop and/or godown is as such, that has been causing traffic disruption in the locality.

- (2) A licensee desirous to shift his shop and/or godown may submit an application for such shifting before the Licensing Authority after fulfilling the following condition:—
 - (i) Proposed shifting must be within 1 km for fair price shop and within 20 kms for distributor's godown from the existing shop and/or godown;
 - (ii) the size and shape of the new shop and/or godown is as per the specification notified by the State Government.
- (3) On receipt of the application, the concerned Licensing Authority shall process the application and get the case enquired into by a competent officer or group of officers and submits the report alongwith his recommendation:—
 - (i) to the Director through the District Controller, Food and Supplies, in case the applicant is a Fair Price Shop owner; or
 - (ii) to the Director in case the applicant is a Distributor.
- (4) On receipt of the recommendation from the District Controller, Food and Supplies, the Director shall consider the recommendation and also form his own opinion regarding shifting of shop and/or godown and after being fully satisfied with suitability of the shop and/or godown, accord approval of shifting on payment of a shifting fee of Rs. 5,000/- in case of Fair Price Shop and Rs. 20,000/- in case of Distributor."
- (3) after clause 31A, insert the following clause:-
 - "31B. Tagging of a Distributor. (1) In case a Distributor has resigned or his license has been suspended, or cancelled or terminated, the concerned Licensing Authority tag the Dealers attached with that Distributor to one or more nearest Distributors preferably located within the range of 20 kilometers.
 - (2) Notwithstanding anything contained in sub-clause (1), in case a Distributor has resigned or his license has been suspended, or cancelled or terminated and the concerned Licensing Authority finds that no Distributor within the range of 20 kilometers is available for tagging of the ration cards, he may select a Distributor located beyond 20 kilometeres.
 - (3) Every tagging made under this clause is purely temporary in nature and such temporary tagging shall not create any right whatsoever in the favour of the distributor with whom the dealers are tagged and such tagging shall automatically deemed to be expired after a period of six months until it is extended by the licensing authority for a further period of six months or until reinstatement of the suspended Distributor or a new license is issued against such vacancy, whichever is earlier.".
