#### **ORDER**

Sub: Creation of posts in Pay Level 21 and 24, awarding benefit under Pay Level 22 and determination of Nomenclature / Designation of the Posts.

Pursuant to Finance (Audit) Department Memo No. 5101-F(P1), dtd. 31.08.2023 read with no. 1297-F(P1), dtd. 11.03.2024, the Governor is pleased to extend the following service benefits to the member of the West Bengal Food & Supplies Service under State Constituted Services of Government of West Bengal:

#### 1. (A) Enhancement of Posts:

## B) Awarding benefit of Scale-19 of ROPA, 1998 (Pay Level-21 of ROPA, 2019):

Terms and conditions: (i) The movement to Pay Level-21 shall be subject to availability of the vacant posts in relevant level in the Pay Matrix for the WBF&SS Cadre and an eligible member of the service shall be appointed against such vacant posts in the next higher level provided the officer has completed minimum 02(two) years of service in the existing Pay Level.

- (ii) The movement to the Pay Level-21 as mentioned above, shall be subject to further condition that the Officer concerned has completed minimum 20 years of service in the WBF&SS Cadre.
- C) Awarding benefit of Scale-20 of ROPA, 1998 (Pay Level-22 of ROPA,2019) Out of 12(twelve) posts in Level-21, two-fifth i.e 05(five)shall be earmarked for upward movement to Level -22, in other words at any point of time, men in position in Level-21 and Level-22 taken together shall not exceed12(twelve)

Terms and conditions: The members of WBF&SS Cadre shall move upward to the pre-revised scale no. 20 (Pay Level-22 of ROPA,2019) on completion of a minimum of 2 years of service in a functional post borne in the pre-revised scale no. 19.

# D) Awarding benefit of Scale -21 of ROPA, 1998 (Pay Level-24 of ROPA, 2019):

Terms and conditions: (i) The movement to Pay Level-24 shall be subject to availability of the vacant posts in relevant level in the Pay Matrix for the WBF&SS Cadre and an eligible member of the service shall be appointed against such vacant post in the next higher level provided the Officer has completed minimum 2(two) years of service in the existing Pay Level.

(ii) The movement to the Pay Level-24 as mentioned above, shall be subject to further condition that the Officer concerned has completed minimum 25 years of service in the WBF&SS Cadre.

2. Nomenclature / designation of the posts in the Pay Level-21, Pay Level-22 and Pay Level-24 will be as follows:
