## **ORDER**

Sub: Revised Head of Account for release of subsidy and other claims of different stakeholders out of the State Budgetary Head of Account w.e.f. 2024-25.

Finance Department, Government of West Bengal has agreed upon the proposal of Food & Supplies Department for creation of new Head of Account under State Development Schemes for various categories of payment for smooth expenditure monitoring, budget estimate preparation cum reconciliation of payment.
