

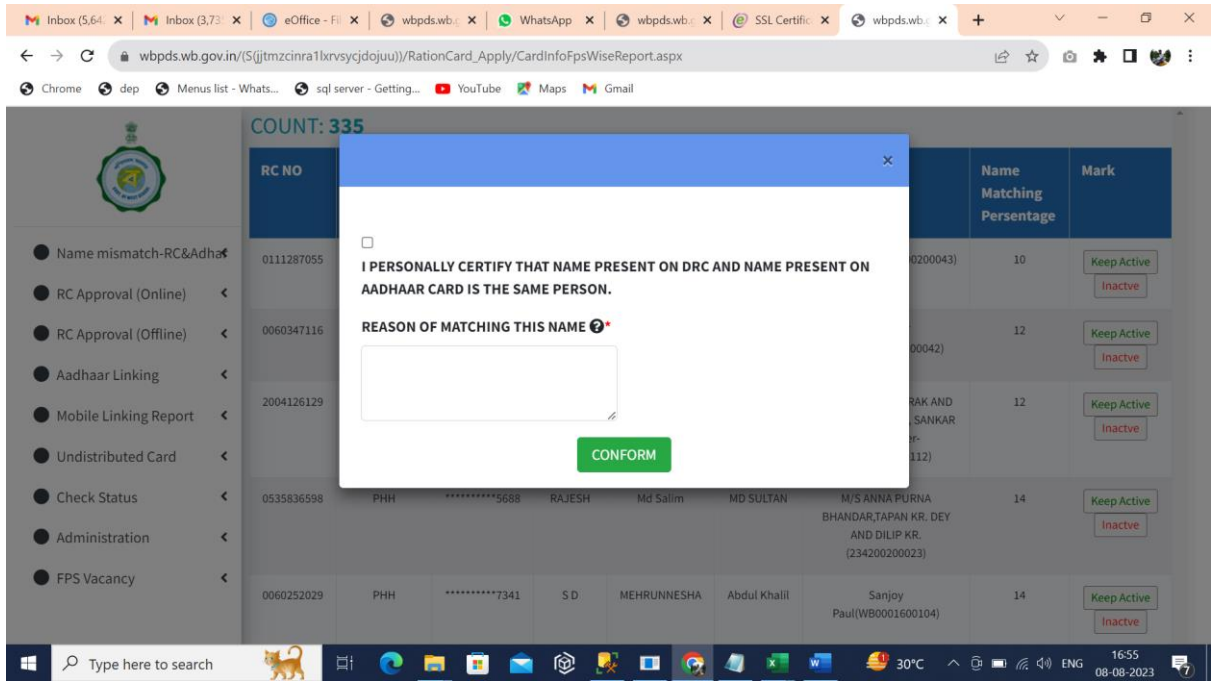

Action from Inspector (F&S) end:

1. Login in at RCMS Portal
2. Click on the menu tab 'Name Mismatch- RC & Adhar'
3. The report will be generate

4. Please check 'Name as in RC ' and 'Name as in Aadhaar' and the Name Matching Percentage score which has been generated by system.
5. There is TWO BUTTONs for action here.
6. Any of these cards can be marked as 'Inactive' if the name of the beneficiary is different than name of the Aadhaar.
7. Any of these cards can be marked as 'Keep Active' if the name mentioned in RC and Name mentioned in Aadhaar belongs the same person. During the process inspector has to certify that the names belong to the same person and has to mentioned the reason of the mismatch in names. Here it's advisable that the name of the RC should be updated with name of Aadhaar through Form 5.



8. Once action has been taken against any of these card that card won't appear in the list again.
9. It's expected that Inspector will finish this list within next 21 days.

#### Action of SCF&S/RO:

The same list is available inside the login of SCF&S/RO . They should monitor the process and check whether Inspector (F&S) is working on the list. It will be the responsibility of SCF&S/RO that action has been taken against all the DRC of his/her jurisdiction within next 21 days.

#### Action DCF&S/DDR:

The same list is available inside the login of DCF&S/DDR. They should monitor the process and check whether Inspector (F&S) is working on the list. It will be the responsibility of DCF&S/DDR that action has been taken against all the DRC of his/her jurisdiction within next 21 days.

#### Action DDPS/DR :

The same list is available inside the login of DDPS/DR. They should monitor the process and check whether Inspector (F&S) is working on the list. It will be the responsibility of DDPS/DR that action has been taken against all the DRC of his/her jurisdiction within next 21 days.
