3. So, he is requested to appoint the above mentioned candidate, who are hereby selected for appointment temporarily against the existing vacancies of Group-D post (Basic Grade), under the administrative control of your Directorate subject to prior observance and compliance for the following formalities:-

- (i) Verification of Certificates/testimonials regarding age and qualification should be made.
- (ii) The characters and antecedents must be verified by the Police Authority and in this regard necessary steps should be taken.
- (iii) Medical Certificate of fitness issued from competent authority should also be obtained.
- (iv) Appointment should be made against a clear vacancy in the Group-D post.
- (v) Any other formalities necessitated under the existing/relevant rules should also be maintained.

4. Employment Exchange Registration Card should be surrendered to the concerned Employment Exchange Authority mentioning therein the date of actual joining of the candidate into the Government Service.

5. Further, Police Verification Report, Medical Fitness Report, Education Qualification, Caste Status of the candidate should be recorded, after their proper examination in the respective Service Book as well as in all other office records in respect of the candidate after his joining to the post physically.


