- 9. The applicant must fulfil the following **eligibility criteria**:
 - (i) The applicant shall be:
 - (a) an individual permanently residing in the Berhampore Sub-division,
 - (b) registered partnership firm,
 - (c) registered Co-operative Society,
 - (d) Sangha Or Mahasangha of Self-Help Groups working within Murshidabad district.
 - (ii) The individual applicant or partners of the registered partnership firm or members of the registered Co-operative Society or members of the Sangha or Mahasangha of Self-Help Groups applying for S.K. Oil dealership must be adult Indian Citizen(s).
 - (iii) If the applicant be Sangha or Mahasangha of Self Help Groups, it shall be working in the (viz. Murshidabad) district.
 - (iv) The godown must be well ventilated pucca structure with a concrete floor.
 - (v) There has to be adequate space in front of the godown for unloading of stock.

Part-3

- 10. Following **person/entity shall not be eligible to apply** for a license of S.K. Oil Dealership, namely-
 - (i) A person holding license of S.K.Qil dealer or S.K.Qil Agent or FPS Dealer or Distributor or Wholesaler in his name or a relative of such licensees.
 - (ii) A member of local bodies, local authority, Panchayati Raj Institutions, board or corporation, or Member of Legislative Assembly or a Member of Parliament during his tenure as such capacity.
 - (iii) A minor or person of unsound mind or an insolvent.
 - (iv) A person convicted by the court under the Act or in any other criminal proceedings connected with essential commodities.
 - (v) A person holding a post in the establishment of any State Government or Central Government or any authority or body or institution of Local self-government established or constituted by or under the Constitution or by any other law made by the Parliament or a State Legislature or by notification issued or order made by the Central Government or a State Government.
 - (vi) A limited liability partnership.
 - (vii) A corporation or company.
