I am directed to refer to the Letter F. No. 2/West Bengal/2014-BP.III dated 08.08.2014 on the subject noted above, received from the Ministry of Consumer Affairs, Food and Public Distribution, Government of India (copy enclosed) and to inform you that the Government of India has kindly allowed one more month's time to implement the provision of its earlier Order No. 1-2/2007-B.P.III dated 11.07.2014 in the matter. It implies that the allocation of food grains for the month up to September, 2014 may be lifted as per instructions/guidelines followed prior to issue of Government of India's Order No. 1-2/2007-B.P. III dated 11.07.2014. However, for upcoming months the lifting should be completed by last day of the month preceding the allocation month.
