ORDER

1. In continuation with this Department's Memo No. 96-JS/FS/P/Sectt/IT-03/2013 dated 15.01.2014 communicating the date of extension for digitization of ration card, it has been further decided that scheduled time for capturing ration card data at the Fair Price Shop level in the main round has been extended upto 28.02.2014 in respective of Kolkata, Howrah, Hooghly, Purulia, Bankura, Burdwan. It has also been decided that the work of digitization of ration card in the main round in respective of the above districts may also be called off in the Fair Price Shop where more than 80% of the ration card population has been digitized . The decision for winding up is to be taken in consultation with concerned DCF&S.
2. In continuation with Memo No. 90-JS/FS/P/Sectt/IT-03/2013 dated 09.01.2014 communicating the operational guideline and time frame for accomplishing the activities of digitization in the five(5) districts viz. Malda, Darjeeling, Municipal areas of North 24 Pgs, Uttar Dinajpur and Jalpaiguri. It has been further decided that the time schedule for capturing ration card data at FPS in the main round in those districts has been extended up to 28.02.2014. It has also been decided that the work of digitization of ration card in the main round in respective of the above districts may also be called off in the Fair Price Shop where more than 80% of the ration card population has been digitized . The decision for winding up is to be taken in consultation with concerned DCF&S.

This order is issued without any prejudice to the condition for accomplishment of the work flow as communicated in the operational guideline.




