#### ORDER

## Sub: Expeditious linking of Ration card with Aadhaar and mobile.

It has been observed that till date large number of ration cards are yet to be linked with Aadhar. In terms of Clause 28 of WBPDS (M&C) Order 2013 and Clause 26 of WBUPDS (M&C) Order 2013 and subsequent amendment thereof shop hours are fixed for distribution of ration. But, for the sake of linking of Aadhar with ration card expeditiously, it is necessity to keep the FPSs open beyond the shop hours for Aadhar linking and allied services other than distribution of ration.

Linking of Aadhaar and mobile is required for providing better service to the PDS beneficiaries.

Now, Government has therefore, decided to keep the FPS open beyond shop hours on all days including Monday for Aadhar linking and allied services other than distribution of ration.

In terms of Duare Ration Scheme Vide Notification No. 3929-FS dated: 16.11.2021 the FPS dealers shall deliver the ration items at the door step of the beneficiaries under West Bengal Duare Ration Scheme. The FPS dealers while going at the door step of the beneficiary for distribution of ration, will link the ration card with Aadhar of all the beneficiaries of the family whose ration card is not already linked.

The FPS dealer shall take every initiative to complete Aadhar linking by 31<sup>st</sup> December 2021 and at least 100 beneficiaries should be covered every day. The FPS dealer should also try to ensure that the family having at least one Aadhar linked beneficiary lift their ration through Aadhar authentication only.

The concerned inspector, Food & Supplies shall monitor Aadhar linking on daily basis at all FPSs under his controls and ensure linking of all ration cards with Aadhar within 31<sup>st</sup> December, 2021. The FPSs not cooperating or giving due importance, shall be identified and appropriate action should be taken.

The concerned SCFS and R.O. will monitor and take necessary action against the errant FPS dealers for non-compliance of the order as well as the performance of concerned Food Inspector of Block or Municipality.
