ORDER

The undersigned is directed to select the names of the 112 (one hundred twelve) candidates enclosed herewith presently holding the posts of LDC & it's equivalent posts attached to the Directorates for filling up the posts of UDC & it's equivalent posts attached to the Directorates on promotion carrying PB-III (Pay Band Scale Rs. 7100-37600/-) plus Grade Pay of Rs. 3600/- along with other usual allowances as admissible from time to time as per ROPA,2009. The Selection Lists of the candidates containing the names of the Directorates where they are now ordered to be allotted on promotion along with other relevant particulars are annexed herewith.

This selection has been made on the basis of the existing Gradation List concerned belonging to the cadre of LDC & it's equivalents maintaining the zone of consideration, referred hereinabove and the Roster has properly been maintained.

The incumbents may, therefore, be appointed accordingly on the terms & conditions as mentioned below:

- 1) The promotion will take effect from the date of issue of this order ;
- 2) The inter-se-seniority of the candidates will, later on, be determined in terms of W. B. Services (Determination of Seniority) Rules, 1981;
- 3) Before issuance of order of appointment so stated, respective Appointing Authority should be fully satisfied that the incumbent concerned is not hit by P&AR Deptt. Memo No. 224-PAR(Vig) dated 12.06.1980 as amended subsequently and this should invariably be mentioned in the order of appointment ;
- 4) Annual Performance Reports and Report on Integrity in respect of the concerned candidates should be examined properly so as to see that they are satisfactory and the same should also be mentioned in the order of appointment ;
- 5) That the incumbents have regularly submitted their respective Asset Declaration Statements should be ensured.
- 6) If anyone of the incumbents fails to satisfy all or any one of the conditions referred above, his name should not be considered for issuing order of appointment and his name should be referred to this Deptt. immediately for it's deletion from the Selection List ;

The present Directors/Heads of Offices of the incumbents should send the Annual Performance Reports, Vigilance Reports, Reports on Asset Declaration Statements in respect of the concerned candidates to the Directorate/Office where their services are allotted to within 15(fifteen) days from the date of issue of this order without any delay on any ground. On receipt of the same, the respective Appointing Authorities should, after observance of necessary formalities, issue order of promotion in favour of the candidates concerned within 15(fifteen) days from the date of expiry of 15(fifteen) days from the date of issue of this order. The candidates concerned should join their new assignments within 15(fifteen) days from the date of issue of order of promotion by the concerned Directorate/Head of Office, without any fail, otherwise, the Order of Promotion will be deemed to have been cancelled on expiry of 45(forty five) days from the date of issue of this order and the concerned Directorate/Head of Office should issue Order of cancellation of Promotion Order in respect of the candidates concerned after the expiry of 45(forty five) days from the date of issue of this order under intimation to this department with recommendation for deletion of the name(s) concerned (if any) from the Select List. Such non-acceptance of the instant promotion should also be recorded in the Service Book of the concerned candidate.

Also, the unwilling incumbents must be transferred from his/her present place of posting and should not be returned to his/her present place of posting up to his/her next promotion. It is to be stated that the names of such candidates will not be considered further for promotion in this cadre before expiry of one calendar year from the date of issue of this order.

In case of the employees who have been kept in the same Directorates except those who will be retired within 31.07.2020, the place of posting will have to be changed and cannot be reverted back within 1 (one) year. The employees who will be retired within 31.07.2020, may be kept in same place, if vacancy arises.

The incumbents, who are engaged with any CPC related works, will perform their duties in the same CPC.

The stipulation of time mentioned hereinbefore should strictly be followed by all concerned.

Further, no prayer for change of allotment on promotion made hereupon should be entertained before joining of the incumbents concerned.

In case, there are cases of spelling errors in names, surnames or any type of clerical mistakes, that may be rectified by the concerned Directorates/offices with an intimation to this Department.

The services of those on deputation to Dtes./offices other than his/her parent Dte./office shall be deemed to be withdrawn herewith.
