4. Service Seniority will be determined according to the West Bengal Service (Determination of Seniority) Rules 1981, read with provisions of Finance Department's Notification No. 1832-F(P) dated 01.03.2013 and amendments from time to time;
5. The DA & HRA are admissible as per Finance Department's Memorandum No. 6712-F(P2) dated 06.11.2017;
6. The incumbent is liable to serve anywhere in West Bengal;

7. The candidate already in Government service will have to furnish the release/resignation certificate issued from the competent authority before joining.

He is hereby also informed that the pre-recruitment formalities like medical fitness report, police verification reports, verification of caste certificates (if applicable) etc. have been done from this end. Copies of PVR & medical fitness report are hereby enclosed herewith for ready references.
