**ORDER**

**Sub: Introduction of online payment to the Flour Millers claim of Transportation, Handling, Crushing, Packing and fortification through IFMS integration.**

Payment of Transportation, Handling, Crushing, Packing and fortification to the flour millers for lifting and Crushing of Wheat and delivery of ATTA were brought into the purview of the online billing module w.e.f. July, 2023 in pursuance of the Order No.3639-IT&R-FNS (Computer No. 424041) dated-06.09.2023. Accordingly, Flour Millers are submitting their claims in digital mode and payment is being credited directly into the Bank account of the flour millers through the integration with SBI.

Since, the fund for Transportation, Handling, Crushing, Packing and fortification to the flour millers are fully given through State budgetary allocation thus it was under active consideration of the Department to make payment directly through Treasury system by way of integration between Supply Chain Portal and IFMS Portal. Accordingly, new Head of Accounts have already been opened in the budget of 2024-25 exclusively for the purpose of budgeting and expenditure towards payment of Transportation, Handling, Crushing, Packing and fortification to the flour millers and integration has also been completed with IFMS.

Henceforth, Directorate of Finance shall make payment of Transportation, Handling, Crushing, Packing and fortification to the flour millers against online bills through IFMS-Supply Chain Portal integrated module only out of the budgetary allocation. Food Cell shall ensure timely submission of fund release proposal to Finance Department and allotment of fund to Director of Finance for timely disbursement of payment.

This order shall take immediate effect.
