Active FPSs are divided into 2 types according to status of the Dealers running them:

- i. Own-run: FPSs which are run by the Dealer who was licenced to run this very FPS.
- ii. Tagged: When the aforesaid originally licensed Dealer has ceased to function (due to death, dissolution of firm, suspension, termination, surrender etc.), the FPS is temporarily tagged to another Dealer.

User accounts of FPS Dealers in webportal <https://food.wb.gov.in/> now will be streamlined to have following features:

1. Discontinued Dealers:

1.1. When a Dealer is discontinued for the reasons of death, dissolution of firm, suspension, termination, surrender etc., the licensing authority i.e. the concerned SCF&S or RO through online module tags the relevant FPS with another nearby Dealer for continuation of PDS as per GO no. 4266-FS dated 01.11.2022.

1.2. In such event when a Dealer has been discontinued and his FPS tagged with another Dealer, user account of the discontinued Dealer will also be temporarily suspended. If he attempts to log in, he will see the message “This Dealer does not have any FPS assigned at present. Please login through account of own-run Dealer (license code < >)”.

2. Functioning Dealers:

2.1. **Dealers with own-run FPS:** Dealers who are running only their own FPS will login using their existing user credentials. In the upper section of his home screen, he will see his Dealer profile. In the lower section he will see the own-run FPS assigned to him. When he clicks on the 'Name of FPS' all the functions of the FPS will open to him.

2.2. **Dealers with both own-run and tagged FPSs:** Dealers who have temporarily been assigned other FPS(s) beside his own-run FPS, on logging in will see all such assigned FPSs.
